Call to Order: President Melanie Heitzman called the meeting to order.

Minutes: Minutes from the previous meeting were reviewed. The minutes were accepted by Mr. Vestal and seconded by Ms. Heitzman.

A List of Transactions for 7/31/2015 through 8/31/2015 was handed out and reviewed by all present. Beginning balance as of 7/31/2015 was \$6,743.69. Ending Balance as of 8/31/2015 was \$4,291.79. Also, Cash Flow for 8/1/2015-8/31/2015 was reviewed. A List of Deposits and Bills from the Director for September 2015 was passed out and reviewed. A motion to accept the treasurer's report was made by Mr. Vestal and seconded by Mr. Wood. Mr. Wood presented some bills to Rita O'Neill for payment. He also completed a check to repay the Gerlachs for show prop materials. A motion to pay current bills was made by Mr. Vestal and seconded by Ms. Heitzman.

New Business: Discussion was held regarding working concessions at the Volleyball Sectionals. There are four dates in October, and two are on dates of our band competitions. Mr. Wood agreed to send out an email and make a decision on this by Friday.

Quarter Auction: Date will be November 20th. A suggestion was made to break the work down into 7 committees. We need an auctioneer. Leanna will talk to someone about this. These should go out in the next two weeks. Concessions: Melanie Heitzman. Set Up/Tear Down: Glen Ray Vestal. Vendors: Leanna Vestal. Floor Manager (for runners and rules): Glen Ray Vestal. Change and startup money: Rita O'Neill. We may plan a special Quarter Auction meeting. Our goal is to raise \$2500.
